The processing and renewal fee is \$78.75 CAD (includes GST) per operator. Payment is due with the application and can be made by credit card, cheque or money order.

#### **Credit Card**

- After your certificate is verified, your application will be sent to Fulford Certification, the card provider
- Fulford will call whoever is making payment employer or operator as indicated on the form for the credit card information
- Please note that the name on the credit card statement will appear as Fulford Harbour Consulting

#### Cheques

- Canadian bank personal and business cheques, and money orders are accepted
