



## Crane Mechanic (Limited Scope, Non-commercial Lift) Application

***A BC Crane Mechanic (Limited Scope, Non-commercial Lift) Licence allows the mechanic to operate in the role of mechanic on behalf of an employer. The licence is restricted to that role and does not allow commercial lifts to be made. The employer is responsible for all lifts.***

3. Provide a passport-sized photo of the operator.

  - Include the head and shoulders.
  - **No hats or sunglasses to be worn.**
