

MOBILE CRANE OPERATOR – HYDRAULIC 80 TONNES AND UNDER

Occupation Description

“Hydraulic 80 Tonnes and Under” operator means a person who operates a mobile crane to perform lifts and hoists, sets up cranes, takes down cranes and plans lifts and crane procedures.

Pathways to Certification

In BC, an individual can become certified as a Mobile Crane Operator – Hydraulic 80 Tonnes and Under by completing the Mobile Crane Operator – Hydraulic 80 Tonnes and Under program or by challenging the certification. All crane operators must be registered with BC Crane Safety prior to applying for SkilledTradesBC apprenticeship registration. Apprenticeship programs are for individuals who have an employer to sponsor them and challenge programs are for individuals who have extensive experience working in the occupation and wish to challenge the certification.

Youth can begin an apprenticeship in high school through the Youth Train in Trades or Youth Work in Trades programs. The Youth Work in Trades program is available for any trade if an employer is willing to sponsor the student. Trades offered through the Youth Train in Trades vary by region; contact your local school district to find out which technical training programs are being offered through the Youth Train in Trades program in your region.

Foundation programs, where available, provide adults and youth who do not have work experience or employer sponsorship with an opportunity to gain the knowledge and skills needed to enter the occupation. Individuals who wish to enroll in a Foundation program must register directly with the training provider.

Recommended Education

The following education is recommended for apprentices entering this occupation. These are not prerequisites, but rather a desired level of skill or knowledge that will contribute to success in the industry.

- Grade 12 or equivalent

BC Crane Safety Registration

BC Crane Safety registration is required for all crane operators in British Columbia. Registration forms are available on the BC Crane Safety website at www.bccranesafety.ca.

SkilledTradesBC Registration

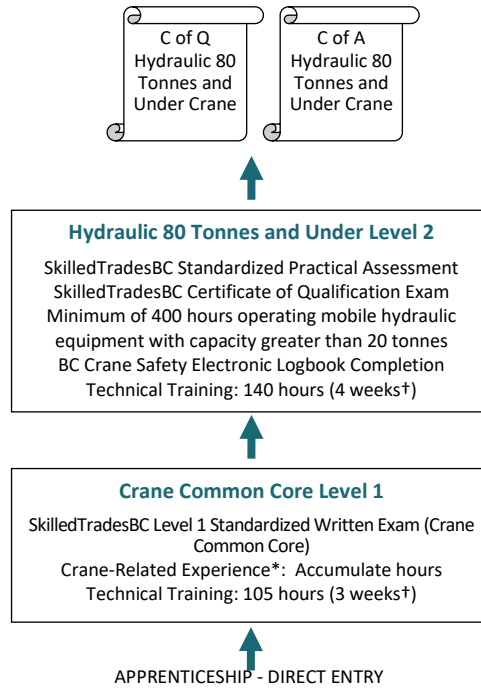
Individuals who wish to begin an apprenticeship in this program must register with SkilledTradesBC along with their sponsor. Application forms for all programs are available from the SkilledTradesBC website. Online registration is also available for most programs through the SkilledTradesBC website.

Those who wish to challenge the Mobile Crane Operator – Hydraulic 80 Tonnes and Under certification must complete the Mobile Crane Operator – Hydraulic 80 Tonnes and Under Challenge Package and submit it to SkilledTradesBC. Challenge applications are assessed for proof of workplace hours and scope of experience prior to acceptance of the individual into the challenge pathway.

Program Duration Duration varies depending on how training is delivered and the type and number of workplace hours that are accumulated.

The technical training requirement is typically met through block-release training (full-time, at school) delivered by a SkilledTradesBC-approved training provider. It can also be met through approved alternative training models (e.g., distance education, online, part-time) and/or level challenge where these options are available.

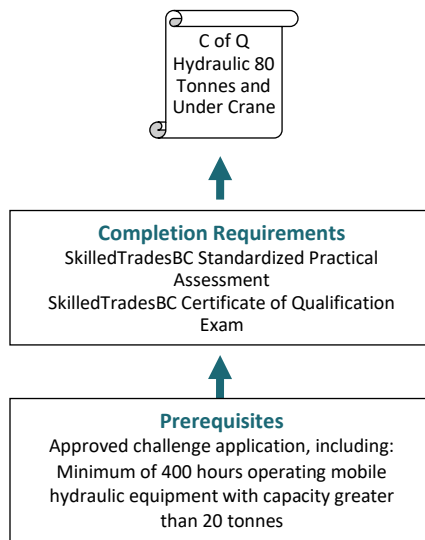
